मुझे यह कहने का निर्देश हुआ है कि डीसीआई की आम सभा ने 18 और 19 सितंबर, 2022 को नई दिल्ली में हुई अपनी बैठक में बीडीएस पाठ्यक्रम की शुरुआत में हर साल 31 अक्टूबर तक एंटी रैमिंग वर्कशॉप/ओरिएंटेशन प्रोग्राम के मामले पर विचार किया।

- 2. इस संबंध में, सामान्य निकाय ने चर्चा और विचार-विमर्श के बाद सभी डेंटल कॉलेजों को बीडीएस पाठ्यक्रम की शुरुआत में हर साल अक्टूबर के महीने में अपने डेंटल कॉलेज में रैगिंग विरोधी प्रकोष्ठों/सिमितियों/दंत महाविद्यालयों के दस्तों के सदस्यों के आविधक प्रशिक्षण के लिए और सभी छात्रों के बीच रैगिंग के बारे में जागरूकता के लिए एक कार्यशाला / सेमिनार / सम्मेलन आयोजित करने का निर्देश देने का निर्णय लिया, जोिक डॉ. आर.के. राघवन, सीबीआई के पूर्व निदेशक की अध्यक्षता में, यूजीसी, नई दिल्ली में 12.06.2014 को आयोजित रैगिंग रोधी निगरानी सिमित के दौरान निर्णय लिया गया था और सभी दंत कॉलेजों से अनुरोध है कि वे आयोजित कार्यशाला/सेमिनार/ओरिएंटेशन प्रोग्राम/सम्मेलन की सीडी/तस्वीरें और उपरोक्त कार्यशाला/सम्मेलन में प्रतिभागियों की सूची डीसीआई को 31 अक्टूबर तक सकारात्मक रूप से प्रस्तुत करें, । आपसे यह भी अनुरोध है कि उक्त एंटी रैगिंग वर्कशॉप/ओरिएंटेशन प्रोग्राम में अपने राज्य या पड़ोसी राज्य (यदि आपके राज्य में उपलब्ध नहीं है) से डीसीआई के किसी एक सदस्य को बुलाएं।

Sir/Madam,

I am directed to say that General Body of the DCI in its meeting held on 18th & 19th September, 2022 at New Delhi considered the matter of conducting Anti Ragging Workshop/Orientation Program in the beginnings of BDS course upto 31st October every year.

- 2. In this connection, the General Body after discussion and deliberation decided to direct all the dental colleges to conduct a workshop/seminar/conference at their Dental College in the month of October every year, in the beginning of BDS course, for periodic training of the members of the Anti Ragging Cells/Committees/Squads of Dental Colleges and for awareness about ragging amongst all students, as decided during the Anti Ragging Monitoring Committee held on 12.06.2014 under the Chairmanship of Dr. R.K. Raghvan, Former Director of CBI at UGC, New Delhi, and all the colleges are requested to furnish the CD/Photographs of the workshop/seminar/Orientation Program /conference so conducted and the list of participants in the above workshop/conference to DCI, by 31st October positively. You are also requested to call any one member of DCI from your State or neighboring State (if not available in your state) in the said Anti Ragging Workshop/Orientation Program.
- 3. Moreover, if any dental college (i) conduct the above said Anti Ragging Orientation program/workshop without inviting any DCI member or (ii) doesn't hold the said Anti Ragging Orientation program/workshop till 31st October every year (or as directed by DCI from time to time), the matter will be placed before the Executive Committee DCI for appropriate action under the provision of DCI Regulations on Curbing the Menace of Ragging in Dental Colleges 2009.
- 4. The aforesaid decision of the Council (18th & 19th September, 2022) of DCI is communicated for your information and further necessary action in the matter.
