#### **11. SCOPE OF SERVICES.**

- 1. The Institute/ College agrees to provide E-waste and the Kumar IT agrees to take charge of the E-Waste created by the Second Party
- 2. The Institute/college shall, at its sole discretion, send written intimation to the Kumar IT either at a specified interval of time or whenever the specified quantity of E-Waste is generated to collect the E-Waste. The Said E-waste shall be collected from the institute/College or any other period as required by the premises and have the same transported from the premises of the institute /college to the Vendor's facility at its own cost and expenses by the guidelines and procedures prescribed by applicable authorities law and instructions of the Institute/College.

#### 111. TERMS OF THE AGREEMENT

- 1. The Second party will prefer the First party for the sale of E-waste scrap available on the campus of the second party. The Second party will collect and do the preliminary sorting process of the E-waste/scrap. It will be stored in the campus storage systems convenient for the first party to loading and transport to their processing centres
- 2. The first party will collect the solid waste generated and collected in specific storage centres on the campus of the second party and will be responsible fully for the processing norms of it as per the terms and conditions of the government authorities.


