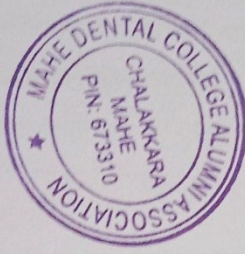

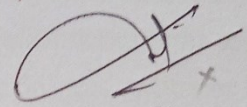

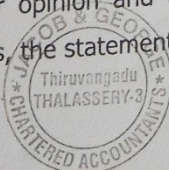
1) We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of the audit.

5) Subject to the above, in our opinion and to the best of our information and according to the explanations given to us, the statements give a true and fair view :-

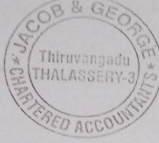




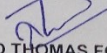
